

On May 4th, the CAC Directors (EAA #393 has a director vote) met at Pine Mountain Lake for the Spring meeting. Present were approximately 20 people and 13 airplanes, all enjoying Chuck and Mary Heath's lovely runway side home. Following is a brief report of the meeting results:

Treasurers Report: CAC is solvent and has enough funds to make 1985 an interesting year. The officers have made several P/R visits, have established the State Regions and Regional V.P.s'. have been active in Statewide meetings with communities and their representatives and we are still able to approve an \$11,500 budget for 85-86.

Publicity: Several new mailers and handouts are now in representatives hands. The CAC will have applications in three papers with major distribution in California. We are fortunate to have Don Garofalo, the Local region Western Flyer representative here at Buchanan.

Annual Meeting: Sheraton Hotel, Concord - October 4-5-6. Ken Edwards has been accepted to be the local committee person and Jan Nileski is the State Chairperson. **EAA #393** has specifically been asked to host an afternoon (1 hour) workshop on homebuilding, and more generally we have been asked to help with manpower, ladypower and graypower! The other local clubs have also been asked to help with an the expected attendance of between 200-400 members and lots of airplanes...more later.

UPDATE ** THE FLIGHT OF THE EAGLES TO OSHKOSH 1985: There is still space available for the seven day trip from Oakland to Oshkosh and back to Oakland....July 26th to August 1st. "OSHKOSH" is the crowning experience of every aviators life. It is the "Mecca" for every person interested in the history and development of aviation technology. It is the greatest showcase of all the types of flying machines ever made by man! The Concorde will make three flights into Oshkosh this year...and will be on display between flights.

The trip includes: round trip air fare (Charter), 7 day/6 night convention tour, round trip motor coach to lodging, in flight meal service, convention lodging, transfers and taxes, paid admission to the aviation center and museum and a preflight party. Based on double occupancy, the total cost is \$419.00 per person. In otherwords, unless you specify a room mate with your reservation, you will be sharing a room with an acquaintance or maybe even a 'new friend' (of the same sex). Also included in the price is shuttle bus service to the convention grounds, lodging assignments complete before departure, free admission daily to the aviation center, convention cafeteria dining at reduced prices and a tour director to handle unforseen problems.

This bill exempts aircraft 35 years old or older (or replica) from property tax if the aircraft is not held primarily for resale, not used commercially or for general transportation purposes, and is available for display periodically to the public.

A one time application for exemption is filed with the county assessor with a \$35 fee.

PURPOSE

WHY HAVE THIS LAW?

- -To promote the preservation of vintage aircraft
- -- To encourage the restoration of vintage aircraft
- -- To promote the display for public enjoyment and education of vintage aircraft PROGRESS AND PLANS

5 Jan Bill Allen, Lorraine Kivi, and Carl Hays went to San Luis Obispo to meet with a local group on this issue.

Jan Bill Allen and Carl Hays met with Senator Jim Ellis to get an bill introduced.

14 Feb SB 971 introduced by Senator Ellis.

17 Apr Bill Allen and Carl Hays testified before the Senate Revenue and Taxation Committee. Bill passed. For - Ellis, Ayala, Bergeson, Deddeh, Seymour. Against - Boatwright, Lockyer, Garamendi.

Mid May Goes before Senate Appropriations Committee. Chairman Alquist, Ayala, Campbell, Dills, Maddy, Beverly, Boatwright, Deddeh, Foran. Hays and Allen to testify.

End April Hays and Allen to testify before state association of county assessors. Their support or opposition could be important.

Summer - Testify before Assembly Revenue and Taxation Committee.

- Testify before Assembly Appropriations Committee.

Bill Allen and Carl Hays have spent a considerable amount of time and money to get this bill to where it is now. They need to testify three more times in Sacramento and once in Modesto. They need all the help they can get to accomplish the following:

- 1. Get letters sent and get others to send letters to the members of the Senate Appropriations Committee before the middle of May.
- 2. Get letters sent to all Senators, preferably by constituents, by I June.
- 3. Get letters sent to all Assemblymen, preferably by constituents, by i July.
- 4. Help in doing large mailings.
- 5. Money for travel expenses, mailings, and a lobbyist in Sacramento.

With \$50.00 from everyone with an antique aircraft and letters to their representatives we can eliminate heavy taxation on all of us forever. If you don't do your part, who is going to do it for you? With your help and contribution we can finish the job. Without it we will all get to keep on paying higher and higher taxes on our aircraft.

JUSTIFICATION

- 1. These aircraft have been on the tax rolls for 35 years. They have paid their dues.
- 2. As described in the bill, these aircraft are flown few hour each year and provide little, if any, burden on aviation facilities.
- 3. These aircraft produce no revenue and provide no transportation to their owners. The only rewards to their owners are flying a piece of history, pride of ownership, satisfaction of preservation, and enjoyment of displaying them to the public.
- 4. The majority of these aircraft are restored over many years by citizens of modest means. To tax them all along the way is unfair.
- 5. Antique automobiles are now exempt form tax and have been for many years.
- 6. Other historical artifacts are not generally taxed because they escape under the general personal property exemption or are unknown the the assessors.
- 7. Many other states do not tax vintage aircraft through exemption or no aircraft tax at all (Minnesota, lows, Nevada, Oregon, Arizona, Etc.).
- 8. The practice of registering aircraft in other states and not displaying them at airshows fearing assessor notice will stop.
- 9. Unless we can educate our youth to connect complex devices with simple things they understand we risk raising future generations which cannot build a better one and are fearful of the fruits of our modern technology. Vintage aircraft help bridge that gap in the aircraft and machinery field.
- 10. Feelings of national pride and a connection to our historical roots are provided to thousands of people at flyins and airshows each year. The cost to taxpayers for this contribution to our quality of living is very small.

IMPACT

Total lost revenue to the state is negligible.

There will be a gain, perhaps substantial, of registrations and the exemption application fee will partially offset that loss.
