NORTHERN CALIFORNIA FLY-IN RULES

In general, we can say that Oshkosh Rules Apply to this FLY-IN. For those who have been to Oshkosh, you know that this means safety, courtesy, and cleanliness standards should be followed. Most of these standards are just good common sense. But, we will highlight several Rules with which you should be familiar:

- · No aircraft in the display compound may be moved without the assistance of wing walkers.
- · No spectators/pedestrians are permitted outside of the display compound. This forbidden area includes the taxiways and runways adjacent to the display compound.
 - · Pilots should comply with all Air Traffic Advisories.
- · Fly-Bys should be conducted no lower that 200 feet and should be to the right of the centerline of the active runway.
 - · No aerobatic flying will be permitted.
- · Each pilot will be responsible for securing/tying down his/her aircraft.
- · Food and drink may not be removed from the food compound.
 - · Alcohol may not be sold or consumed on the airport.
- · Keep the airport clean—Place all trash in the trash receptacles.
- · Attendees should not bother FBO office. Legitimate reasons to visit the office might be to order fuel or other services.
- · Cars should be parked only in the designated parking areas. Cars parked in other areas may be towed to a safe location.
