PRESIDENT'S MESSAGE

EMERGENCY!!

FAA proposes massive new airspace restrictions... will you be grounded? PLEASE ACT NOW! Deadline 3-28-88! NPRM 25531, Notice 88-2 would require Mode C (transponder with altitude encoder) on any aircraft:

- 1) above 6,000 AGL and
- 2) within 46 miles of any radar approach control service (virtually all of northern & southern California)

Also, the floor of controlled airspace would be 1,200 ft. everywhere, which means 3 mile visibility required.

Please contact your congressman, senators and the FAA. HERE'S HOW:

- 1) Check out the info in Sport Aviation, page 6, March 1988
- 2) Write your own letter, best way, or use the "pre-composed" ones included with this newsletter. It must be dated, signed, and should have a hand written comment.
- 3) If possible, please make 2 copies to wind up with 3 total, one to your congressman (probably George Miller), one each to Pete Wilson and Alan Cranston.
- 4) Make 2 copies of any letters you send, and send those copies to:


If you don't think this will affect you, please refer to the diagram on the next page. You will also find the mailing address for Senators and Congressmen there.

There's a rumor circulating that land developers are pressuring the Port of Oakland to close Oakland Airport's North Field, convert it to "light industry" and create a thoroughfare connecting the Harbor Bay Business Park with 880. This coincides conveniently with a "huge" public outcry against the airport by citizens living in the Fernside district of Alameda and spurred by certain members of the Alameda City Council. It's interesting that the airport should all of a sudden create a noise problem, especially when it and the Fernside district have coexisted for more than 40 years. On the subject of noise, those Fernside residents who complain that it's not coming from the airport, but from the increased ground traffic going to Harbor Bay seem to be ignored.

Closing North Field and turning it into a freeway would certainly solve a lot of problems for the developers. Stay tuned.
